## Lift Chair (aka Seat Lift Mechanism) <a href="Insurance Coverage Criteria">Insurance Coverage Criteria</a>

## Medical Records Documenting:

- 1. The patient must have <u>severe</u> arthritis of the hip or knee OR have a <u>severe</u> neuromuscular disease.
- 2. The seat lift mechanism must be a part of the treating practioner's course of treatment and prescribed to effect improvement or arrest or retard deterioration in the patient's condition.
- 3. The patient must be completely incapable of standing from a regular armchair or any chair in their home. (The fact that a patient has difficult or is even incapable of getting up from a chair particularly a low chair is not sufficient justification for a seat lift mechanism. Almost all patients who are capable of ambulating can get out of an ordinary chair if the seat height is appropriate and the chair has arm.)
- 4. Once standing the patient must have the ability to ambulate.

## **Special Notes:**

- The treating practioner ordering the seat lift mechanism must be the treating practioner for the disease or condition resulting in the need for a seat lift.
- The treating practioner's record must document that all appropriate therapeutic modalities (i.e. medication, physical therapy, etc.) have been tried and failed to engage the patient to transfer from a chair to a standing position.
- Insurance coverage for this code E0627 does not always cover the entirety of the chair and the patient may have out of pocket expenses related to this item.
